<p>The majority of Beauticians carries out their profession as a self-employed person without any employees (zzp). She owns her company or works as an ambulant. She could also be employed as a manager. Possible working environments are: a beauty salon, wellness centre, sauna, drugstore, or perfumery. The Beautician has several beauty treatments on offer. She focusses on the treatment of a healthy skin and nails.</p>

<p>Access to next level of education/professions A Beautician can be promoted to an all-round beautician. Further growth is possible becoming a manager or a self-employed person. She could also be transferred to the qualifications Pedicure and All-round hairdresser.</p>	<p>International agreements The profession of a Beautician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
 In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
 In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
