- 1.3 Maintenance of workplace and tools.

Core task 2: Repairs leather goods and leather products.

- 2.1 Performs preparatory works.
- 2.2 Repairs and finishes leather products/leather goods.

Core task 3: Gives advice and sells

- 3.1 Assesses the (reparation) requirement
- 3.2 Assesses and give advice about the repair.
- 3.3 Advices about leather goods and (by)-products.
- 3.4 Registers and completes sales repair
- 3.5 Deals with complaints.
- 3.6 Presents articles.

Core task 4: Designs the shoe

- 4.1 Focuses on the assignment.
- 4.2 Develops the design and arranges for it.
- 4.3 Measures feet

Core task 5: Manufactures shoes

- 5.1 Prepares for the manufacture of the shoe
- 5.2 Adjusts the commercial sizing last and makes a model

The Made-to-measure shoemaker works mostly in small companies comprising one to a couple of employees at most. Besides being an entrepreneur he is a specialist if it comes to designing and producing shoes.

He could also train himself in the field of orthopaedic shoe technology. Of course, he could also follow courses in other professions which may or may not be related.</p>	<p>International agreements The profession of Made-to-measure shoe maker is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
