3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Commercial employee insurance are:

The Commercial employee insurance acts independently in advising on the sale of various insurance services and products to private customers. The range of tasks is focused on insurance services. In addition, he has general tasks in the field of marketing planning, commercial matters, modern foreign languages and callcenter related activities. His work consists primarily of advising customers on insurance products. The Commercial employee insurance must have sound, substantive knowledge of the products, and must be able to empathise clearly with the customer's situation. He must be able to meet the customer's expectations, to prevent the customer going to competing organisations. The majority of work takes place in front-office situations, focusing on advisory and sales activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Commercial employee insurance can work in various middle management positions in insurance companies, in insurance brokers or in banks. Positions such as insurance advisor, insurance agent or insurance broker.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Commercial employee insurance is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
