5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Qualification level 4 of the Dutch VET qualification structure</p> <p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. <p><b>Access to next level of education/professions</b></p> <p>Having completed this course of studies, transfer is possible to higher professional education.</p> <p>Depending on experience and schooling, the Supervisor traffic and urban development can grow into more responsibilities and managing larger and/or more complex projects or a specialist function with greater responsibilities. Educational possibilities for that purpose are: related hbo programmes Geodesy and geo-informatics or Environmental planning.</p>	<p><b>International agreements</b></p> <p>The profession of Supervisor traffic and urban development is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p><b>Legal basis</b></p> <p>Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94054</p> <p>The education and training for this qualification is offered as of August 1, 2008.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 year(s) (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b></p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
