2.2 Checks the (storage) specifications for ingredients and products on receipt

2.3 Stores the products supplied in temperature-controlled spaces

Core task 3: Improves on assortment quality and appeal

3.1 Advises customers on bakery products

3.2 Strives for high quality operational processes and routing on the work floor

3.3 Comes up with ideas to expand the range and develops recipes

Core task 4: Carries out supervising tasks

4.1 Devises an operational plan

4.2 Plans and assigns tasks

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Manager bakery works within the bakery branch of industry. He works within a (artisan) bakery or a department in large manufacturing companies.

The Manager bakery generally carries out his tasks early in the morning in specific production environments. The arrangement and conditions of these production areas are dependent on the bakery products that are made.

Access to next level of education/professions In most bakeries, Manager bakery is the highest position, although in the labour market he can develop to attain a management position or continue as an entrepreneur. It is possible to develop through educations such as Associate degree Small Business, Retail management, Higher professional food technology (specialised in bakery technology) or the Teacher's course Bakery (consumer technology).	<b>International agreements</b> The profession of Manager bakery is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25172 The education and training for this qualification is offered as of August 1, 2015.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the<br/>training on the job pathway (bbl).In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical<br/>component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of<br/>vocational practice is at least 60% of the course. The participant works four days a week in a training company,<br/>and attends school for theory subjects just one day a week.In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the<br/>individual educational institution.Average duration of the education/ training3 years (4800 study hours) (depending on
