- 1.8. Carries out preparatory work

Core task 2: Carries out administration and management

- 2.1. Plans administrative activities
- 2.2. Monitors the status of sales transactions
- 2.3. Processes changes and cancellations
- 2.4. Monitors timely payment
- 2.5. Deals with invoices and travel documents
- 2.6. Undertakes relationship management
- 2.7. Deals with complaints and insurance claims
- 2.8. Monitors trends and developments on the travel market

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Salesman holiday travels is employed in the travel industry at travel agencies.

Access to next level of education/professions

With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.

International agreements

The profession of Salesman holiday travels is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of gualification (crebo): 90652 The education and training for this qualification is offered as of August 1, 2005.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information in section 3 and 4 is drawn directly from the qualification file, that is composed by the Centre of Expertise.
