3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Nurse (general care) are:

A Nurse (general care) is capable of planning and implementing nursing activities, interventions and activities in the field of prevention, health information and education and information, according to standard procedures and combinations of standard procedures in complex situations. She registers the effects of her activities and interven-

A Nurse (general care) is responsible for implementation of the nursing process with the following phases:

- case history;
- nursing diagnosis;
- drawing up and if necessary adjusting a nursing plan;
- implementation of nursing care both somatic and psycho-social;
- evaluation of the nursing care provided.

A Nurse (general care) organises and coordinates the nursing care for the care recipient. She carries out a number of peripheral responsibility tasks, such as quality assurance and professional improvement. She reports relevant details to relatives and colleagues.

A Nurse (general care) recognises and analyses nursing problems, assuming a complex nursing situation for a patient, and the patient care requirements, and on that basis plans, organises, implements and evaluates the individual nursing programme.

Nursing activities:

- -Administer medication and provide treatment;
- Provide nursing care according to nursing standards:
- -Observe, register and report on the condition of the patient and the reactions to medication and other treatments.
- -Bear responsibility for coordination and continuity of care:
- -Supervise trainees in implementing the nursing process:
- -Plan and organise the work in a nursing unit, cooperate with other care-provision disciplines (including medical specialists, members of medical teams, care providers and professionals with other disciplines) and with patients and their relatives:
- -Provide a contribution to prevention;
- Provide patient information.

Other nursing activities are catheter care, colostomy care, subcutaneous, intramuscular and intravenous injection, administration of a medicine via a drip system, application of a peripheral drip, application of an infusion pump and

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
