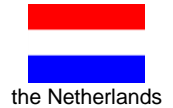

<p><b>Access to next level of education/professions</b> For the Bicycle mechanic there is no continuous education track to levels 3 and 4, except when he/she transfers to Motorcycle technique or (Commercial) Car technique. Within the branch, however, there are possibilities to move on for the Bicycle mechanic. Obvious is, of course, the move to a higher position, for example contributing workshop manager. Besides moving on, a worker can also broaden his possibilities within the branch by specializing in a certain field. The Bicycle mechanic can further specialize as an electro, ATB, and racing bike specialist.</p>	<p><b>International agreements</b></p>

**6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE**

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
