3. Profile of skills and competences

The most important duties of an Assistant manager wood assembly industry (level 4) are:

Core task 1: Processes wood/ sheet materials using machines and tools

- 1.1 Prepares machine working duties
- 1.2 Assembles supplementary product data
- 1.3 Selects, inspects and transports wood and sheet materials
- 1.4 Applies and adjusts cutting tools
- 1.5 Adjusts wood processing machines and/or tools
- 1.6 Carries out test process
- 1.7 Carries out processes using wood processing machines and/or tools
- 1.8 Clears up the workplace
- 1.9 Carries out simple maintenance

Core task 2: Assembly

- 2.1 Prepares assembly working duties
- 2.2 Selects, inspects and transports materials and tools
- 2.3 Assembles frames from wooden frame elements and/or exterior wall elements
- 2.4 Completes assembly of frames from wooden frame elements and/or exterior wall elements
- 2.5 Attaches exterior wall elements
- 2.6 Prepares assembly exterior wall elements
- 2.7 Hangs windows and doors in exterior wall elements and makes them able to close
- 2.8 Applies sealant fillings in exterior wall elements
- 2.9 Installs appliances and provisions to exterior wall elements
- 2.10 Makes ready for delivery
- 2.11 Clears up the workplace
- 2.12 Carries out simple maintenance

The Assistant manager wood assembly industry works for companies focused on producing wall elements (window frames, windows, doors), exterior wall elements and/or wooden frame elements (wall, floor, and roofing elements).

The Assistant manager wood assembly industry can rise to the profession of planning officer. A diploma at level 4 gives access to higher vocational education. Higher vocational education programmes such as for Technical business administration, Industrial product design, Human technology and Architecture are the most logical step.

The profession of Assistant manager wood assembly industry (level 4) is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94630 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
