3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic medium voltage distribution are:

Core task 1: Install, assemble and prepare distribution network for use

- 1.1 Prepares for working duties and organises work location
- 1.2 Digs trenches and wells

1.3 Lays and assembles distribution networks

1.4 Makes constructed and mounted distribution network ready to use

1.5 Finishes and does administrative work for construction and assembly work

Core task 2: Installs and works on medium voltage distribution grids

2.1 Does preparatory work in medium voltage distribution grids

2.2 Assembles installations and components

2.3 Monitors, tests/tries and checks medium voltage distribution grids

2.4 Administers and finishes off working duties

Core task 3: Maintains and repairs medium voltage distribution grids

3.1 Does preparatory work for maintenance and repair work on medium-voltage distribution grids

- 3.2 Maintains, replaces and repairs components in medium-voltage distribution grids
- 3.3 Makes serviced/repaired medium-voltage distribution grids ready for use

3.4 Administers and finishes off maintenance and repair working duties

Core task 4: Organises work to be carried out

4.1 Divides up working duties and gives instructions

4.2 Supervises the work to be carried out

4.3 Monitors progress of the work to be carried out

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Skilled mechanic medium voltage distribution works in the energy distribution sector. Usually he works for contracting, installation or grid companies.

He carries out various tasks on medium voltage distribution grids, such as installing medium voltage distribution grids, assembling medium voltage distribution components and build connections for clients consuming on a large scale and medium voltage distribution grids.

Access to next level of education/professions A Skilled mechanic medium voltage distribution can expand his professionality to become a Skilled mechanic low voltage distribution or develop to become a Technician electro-technology, building site constructor or planner.	International agreements The profession of Skilled mechanic medium voltage distribution is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25270 The education and training for this qualification is offered as of August 1, 2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
