3. Profile of skills and competences

The most important duties of a Branch manager are:

The Branch manager supervises a small establishment of a central planned chain. He manages a team of (junior) shop assistants and sales specialists. He has an overview of the establishment: he coaches and supervises all tasks in the establishment. If necessary he also participates in sale and cash register activities. The Branch manager is responsible for the turnover of his branch-store and takes all kinds of decisions to obtain and to increase that turnover. He gears the policy of the branch to local situations, but within the framework of the head office. He thinks along with the total policy of the branch and will do proposals if necessary to change that policy. The Branch manager knows as no other that to keep things going well in a shop it takes motivated employees. Managing personnel and creating a good working climate are important tasks of the Branch manager.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
