- 1.3 Makes orthoses or prostheses
- 1.4 Makes orthoses or prostheses ready for fitting
- 1.5 Adjusts and finishes off orthoses or prostheses
- 1.6 Adjusts (semi) mass-produced articles

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An Orthopaedic technician works in an orthopaedic technical company.

5. OFFICIAL BASIS OF THE CERTIFICATE

Within his field of expertise, the Orthopaedic technician can specialize in one area, such as the production of orthoses or prostheses. He can also decide to do the advanced training for Advisor technical provisions in healthcare (level 4).

The profession of Orthopaedic technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92860
The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
