## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Stage and event technician are:

Core task 1: Actualises product

- 1.1 Checks the operation of the installation and equipment
- 1.2 Operates apparatus
- 1.3 Actualises (floor) scene changes

Core task 2: Prepares production technically

- 2.1 Gathers the necessary equipment and materials and makes them ready for use
- 2.2 Transports materials to the construction site
- 2.3 Furnishes the production location and completes it
- 2.4 Places, hangs and connects apparatus and means
- 2.5 Keeps technical equipment and supplies operational
- 2.6 Does dry run with technical equipment for the benefit of production

Core task 3: Prepares production

- 3.1 Maintains his network
- 3.2 Collects information on the production

Core task 4: Performs tasks supporting production

- 4.1 Organises administrative and financial matters
- 4.2 Coordinates the work
- 4.3 Operates single lift or hoisting equipment
- 4.4 Adjusts apparatus
- 4.5 Supplies installation
- 4.6 Deals with disruptions during the performance

A Stage and event technician can work at various organisations, such as theatres, production houses, travelling companies, events, festivals and pop music venues, but also at equipment rental companies and specialised employment agencies.

The Stage and event technician works all-round in the area of stage technology.

<p><b>Access to next level of education/professions</b> A Stage and event technician can develop to become a Stage and event technician sound, lighting or stage &amp; rigging. Through further education and work experience, he can develop to become a stage technician, audio-visual worker, audio-visual specialist, stage master, stage manager or head of technology. Career planning is important, due to the heavy physical strain that comes with the profession.</p>	<p><b>International agreements</b> The profession of Stage and event technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25203 The education and training for this qualification is offered as of August 1, 2015.</p>																					

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
