The most important duties of a Cook are:

The main tasks of a Cook are to carry out preparatory work and create products based on recipes. An important point of attention in training is the professional attitude of a cook. This involves the development of social skills and personal qualities (specifically independence and flexibility) and working safely. This, in combination with the command of professional skills, will enable a Cook to develop sufficient self-confidence to find his way within a vocation that is constantly on the move.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

This function may be found in the hospitality and catering business, institutional kitchens, contract catering and recreation, and within these branches in a variety of businesses involved in the production and provision of meals

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
