## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Aviation operations officer are:

Core task 1: Coordinates the ground operations process

- 1.1 Coordinates and collaborates in the ground operations process on location
- 1.2 Is responsible for the flow of information in the ground operations process
- 1.3 Directs in case of defects in the ground operations process
- 1.4 Makes suggestions for improvements in the ground operations process
- 1.5 Provides functional leadership to colleagues

Core task 2: Takes care of the flight operations process

- 2.1 Makes a flight plan and communicates about this with those involved
- 2.2 Determines the aircraft performance
- 2.3 Supervises the flight remotely
- 2.4 Deals with defects in the flight operations process

Core task 3: Takes care of the load control process

- 3.1 Makes and communicates a loading plan
- 3.2 Deals with special and mixed consignments
- 3.3 Deals with defects in the load control process

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Aviation operations officer works for an airline company or dealer, an airport port service, or supporting departments for the air traffic control.

<p>Qualification level 4 of the Dutch VET qualification structure</p> <p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. <p><b>Access to next level of education/professions</b></p> <p>After additional training and/or proven competencies, the Aviation operations officer can rise to the position of duty manager, dispatch and turnaround coordinator. He can also enter the higher vocational education programme for aviation at the Hogeschool van Amsterdam. In addition, the Scheepvaart en Transport College and the Nationale Hogeschool voor Toerisme en Verkeer offer relevant advanced courses.</p>	<p><b>International agreements</b></p> <p>The profession of Aviation operations officer is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 year(s) (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b></p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
