The Assistant dental technician assists in producing dental and orthodontic work pieces that dentists need for their patients. He/she for example works with plaster casts for dentures. The Assistant dental technician performs: casting, modelling, unbedding, abrading, soldering, finishing, grinding and polishing. He/she complies with the instructions relating to health, safety, hygiene and the environment. The Assistant dental technician is also involved in patient treatment. He/she listens to what the patient expects of the treatment, and how the patient experienced the treatment.

The study programme consists of the following compulsory partial qualifications:

- crown and bridgework 1
- orthodontics 1
- partial dentures 1
- full dentures 1
- work preparation

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<b>Average duration of the education/ training leading to the certificate</b>	<b>2 years (3200 study hours) (depending on previous education)</b>
<b>Entry requirements</b> <p>The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
