The most important duties of a Beautician are:

- 1.1 Receives the client and makes up treatment plan
- 1.2 Advises clients and sells products and services
- 1.3 Completes treatment
- 1.4 Taking care of an orderly and hygienic salon

Core task 2: Carry out a beauty treatment

- 2.1 Carries out facial treatment
- 2.2 Carries out hand, nail and foot treatments
- 2.3 Carry out a body treatment

Core task 3: Runs a business

- 3.1 Analyse the market
- 3.2 Start a company
- 3.3 Shape the company
- 3.4 Present and promote the company
- 3.5 Carries to purchasing and stock policies
- 3.6 Carry out (financial) administrative working duties
- 3.7 Evaluate the company

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Beauticians work in the sector beauty care. Beauticians can work in the following environments: a beauty parlour, beauty farm, sauna, chemists or perfumery. In addition, they can do promotion work, work as a representative for large brands or run a business. Most Beauticians are self-employed in a parlour at home with no staff.

<p>Access to next level of education/professions With the certificate of Beautician, transfer is possible to a middle management or specialist course (qualification level 4). The Beautician can rise to the position of all-round beautician. Working as a training instructor is also a possibility. Furthermore, promotion is possible as a business manager, a management position, or self-employed entrepreneur.</p>	<p>International agreements The profession of Beautician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95500 The education and training for this qualification is offered as of August 1, 2011.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
