3. PROFILE OF SKILLS AND COMPETENCES

The Branch manager of a supermarket or chain store supervises and coordinates activities relating to goods, customer and monetary flows in the branch. He/she also cooperates in the implementation of these activities. The following subjects are covered in the course of studies for Branch manager: management, human resource management, store design and care, planning and organising daily activities and sales promotion.

The course of studies Branch manager consists of the following components:

- branch management
- retail marketing
- sales
- sector differentiation (choice includes foods, shoes, textiles, DIY, sports and perfumes)
- management skills
- presentation and promotion
- stock control and cashing up
- human resource management (recruitment, supervision, administration)
- modern foreign language

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Branch manager operates independently in a branch of a chain store.

5. OFFICIAL BASIS OF THE CERTIFICATE	
Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. Access to next level of education/professions With a diploma at qualification level 4, transfer is possible to higher professional education. For example to the course of studies Commercial Economics or Small Business and Retail Management.	International agreements Branch manager is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
