The most important duties of a Health care provider are:

Core task 1: Offers care and support on the basis of nursing plan

- 1.1 Draws up nursing plan
- 1.2 Supports with personal basic care
- 1.3 Offers palliative/terminal care
- 1.4 Supports with housekeeping and housing
- 1.5 Performs nursing activities
- 1.6 Monitors the somatic and psycho-social health situation
- 1.7 Gives individual information, advice and instruction
- 1.8 Handles crisis situations and unforeseen situations
- 1.9 Offers maternity care

Core task 2: Supports the care recipient(s) on the basis of nursing plan

- 2.1 Supports a care recipient in his/her ability to live independently
- 2.2 Supports a care recipient in the psycho-social area
- 2.3 Supports a care recipient in the social area
- 2.4 Supports a group of care recipients in the social area

Core task 3: Performs duties for care provision and organisation

- 3.1 Consults about the care provision
- 3.2 Evaluates the care provision
- 3.3 Participates in various consultation methods

Core task 4: Performs profession-related duties

- 4.1. Works on professional advancement
- 4.2. Works on professionalization

The holder of this diploma is qualified to work as Personal health care provider (Verzorgende-IG) in the Netherlands.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Health care provider in nursing and convalescent homes and home care works in a nursing home, a convalescent home, the home situation, small-scale housing or in an assisted living complex. The care services in this branch are increasingly individually oriented and provided in the care recipients' home

The Health care provider in mental health care provides care in intra-, trans- and extramural settings, such as: integrated mental health care institution, general psychiatric hospital, RIAGG (regional institute for mental welfare), regional institutions for assisted housing, child and youth psychiatric institutions, institutions for care and treatment of drug addicts, institutions for forensic care, home situation or a combination thereof.

Because people with a psychiatric care demand are treated as closely to home as possible, Health care providers in this branch will receive more care demands that shift to the home situation of the care recipient.

The Health care provider in care for the disabled works in various care contexts, among which institutions for the handicapped (intramural), small-scale assisted housing, day-care projects, or in the home situation of the handicapped person who lives independently or with parents/caretakers or in a combination of the before-mentioned work settings.

The Health care provider in maternity care generally works on his/her own in the home situation of the care recipient. Sometimes he/she works in the hospital or in a maternity care hotel.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the
