- 1.5 Serves the order and tidies away
- 1.6 Creates a suitable atmosphere
- 1.7 Monitors the atmosphere
- 1.8 Settles payment of the order and sees guests out

Core task 2: Carries out preparatory and concluding tasks

- 2.1 Carries out preparatory tasks
- 2.2 Carries out concluding tasks
- 2.3 Cashes up the cash register

Core task 3: Manages stock and orders new stock

- 3.1 Checks stock and orders new stock
- 3.2 Receives and checks deliveries
- 3.3 Unpacks deliveries and stores the delivered items

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Host/hostess works in establishments where meals and drinks are served.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
