4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Specialist cultivation and technology works in the primary sector on a plant cultivation company. This sub sector includes vegetable cultivation, bulb cultivation, potted plant cultivation, mushroom cultivation, cut flowers cultivation, agriculture, olericulture, bulb-growing cultivation, tree and plant cultivation, fruit cultivation or a combination of these cultivations. Depending on the cultivation, the Specialist cultivation and technology works in the indoor farming or the outdoors farming.

The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education, Culture and Science pupil attended the programme.

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. Access to next level of education/professions

Via experience and/or training, to a limited degree, a switch is possible to the position of business manager and/or self-employed entrepreneur in another sector. both inside and outside the agricultural field. Next to this, the Specialist cultivation and technology can continue to develop within the sector to a specialist in one of the parts: for instance, climate control, energy management or crop protection. As a specialist in one of these fields, he could also work as an advisor/account manager for a supplier in horticulture technology.

International agreements

The profession of Specialist cultivation and technology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of gualification (crebo): 97682 The education and training for this qualification is offered as of August 1, 2010.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
