- 3.4 Completes the inspection or test working duties

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round mechanic mobile machinery works in the sector technology (Kenteq)/construction & infrastructure (Fundeon). He works in the road and waterway sector and in agricultural machinery on mobile internal transport means, mechanised businesses and/or rental companies. He works in small, medium-sized and large companies, but also as a self-employed person with no staff.

<p>Access to next level of education/professions The All-round mechanic mobile machinery can develop into a qualification at level 4, for instance the qualification of Planner, Agricultural machinery technician.</p>	<p>International agreements The profession of All-round mechanic mobile machinery is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92151 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
