3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor materials technology are:

- To determine and check the properties of many types of materials using various types of equipment and machinery;
- To administrative register, process, store and report measurements;
- To process and treat materials within the context of product R&D;
- To monitor the quality of production processes according to instructions and, in some cases on the basis of measurements, to adjust the production process (or give instructions for adjusting it);
- To be able to design simple objects according to set requirements.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Supervisor materials technology generally works in the chemicals, rubber or plastics industry, the pottery industry or the metal, machine or transport equipment industry. He/she generally works at the R&D department, production or quality department under the supervision of a department head.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Supervisor materials technology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
