3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Social pedagogical carer child care are :

- providing physical care;
- nutrition-related care;
- providing individual and group supervision:
- encouraging the individual development of a child:
- offering activities and playing options adapted to the age and development of the individual child or a group of children:
- creating a safe environment;
- handling deviant behaviour;
- ensuring health and prevention;
- carrying out observations and competent referrals;
- encouraging and counselling parent participation and parental contacts;
- participating in policy implementation:
- accommodation management;
- office activities;
- teamwork;
- providing work supervision for trainees and volunteers;
- promotion of expertise;
- taking responsibility for rooms and materials;
- undertaking light domestic tasks.

The Social pedagogical carer child care is active in the provision of care and services in the framework of the primary (replacement) residential and life situation. The professional character of the care and service is expressed in the planned, targeted and method-based structure, and the practitioner in this profession is responsible for the group of children between the ages of 0 and 12. The Social pedagogical carer child care is capable of bearing responsibility for drawing up an individual (care) plan. The Social pedagogical carer child care also bears responsibility for the provision of care and services.

- Professional attitude aspects of the Social pedagogical carer child care are demonstrated:
- interpersonal skills in respect of children, parents and colleagues;
- awareness of professional approach;
- awareness of own values and standards and those of others;
- intercultural working as a basic approach;
- approach to education based on a vision on child rearing.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
