## 3. Profile of skills and competences

The most important duties of an All-round construction worker are:

Core task 1: Manufactures products

- 1.1 Does preparatory work for working duties
- 1.2 Set and adjust machine and tools
- 1.3 Berekeningen maken en plan van aanpak opstellen
- 1.4 Manufacture and transform material
- 1.5 Connecting (building together, assemble, fixing) of parts/partial products
- 1.6 Carry out repairs and modifications
- 1.7 Supervise less experienced colleagues
- 1.8 Measure and check manufactured products
- 1.9 Rounding off work carried out

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round construction worker carries out working duties in the metal production industry and is employed by big companies such as, companies which build steel constructions, the shipping industry, maritime shipping industry, machine building, equipment construction, petrochemistry, offshore, transport means and food industry. He also works for smaller companies, supplying companies for the electro technical industry, the building sector and several repair companies.

## Access to next level of education/professions

The certificate All-round construction worker gives access to a middle management programme (qualification level 4).

Within metalworking (welding, construction, sheet and pipe working) the All-round construction worker can move up to planner or construction specialist. Through work experience he can also develop into assistant manager.

## International agreements

The profession of All-round construction worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94312 The education and training for this qualification is offered as of August 1, 2012.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

# **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
