3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Printer are:

Core task 1: Preparation and realisation of production

- 1.1 Plans his work based on order information and/or other works.
- 1.2 Sets up workplace for the production
- 1.3 Sets up the machine and operates it during and after the production.
- 1.4 Ensures maintenance of the machine.
- 1.5 Monitors the quality of the production process.
- 1.6 Completes the work activities.
- 1.7 Completes the administration and archives production data and/or files.

Core task 2: Organisation and optimisation of the production.

- 2.1 Discusses and coordinates production (planning) with stakeholders.
- 2.2 Solves technical problems.

Core task 3: Preparation of digital printing.

- 3.1 Makes files suitable for production on machine in question.
- 3.2 Solves technical problems.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Printer is employed by graphic arts companies which produce printed matter of all sorts and types: magazines, newspapers, advertising material, house styles, brochures, catalogues but also labels, wall paper, packaging, prints of clothing and fabrics.

<p>Access to next level of education/professions The Printer can move on and be trained to become a Print media technologist. Career prospects for a Printer come down to expanding to a position at middle management level when taking additional trainings.</p>	<p>International agreements The profession of Printer is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25208 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
