3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Manager household goods - interior advice are:

The Manager household goods - interior advice manages and is responsible for tasks relating to sales and advice for the laying out of an interior space. This involves the interior design of homes, offices, shops and other properties. Together with the client, the manager formulates a tailor-made purchase. He organises the space to be designed and lays down his ideas and the wishes of the client in a design. He communicates about the design to the client, draws up an offer and order note and reaches agreements on delivery/implementation of the design. As the need arises, the Manager household goods - interior advice implements the order and is responsible for implementation following order confirmation.

The Manager household goods - interior advice is focused on promoting the quality of the services with a view to increasing sales and customer satisfaction. He deals with any complaints and proposes improvement measures. He coordinates and jointly undertakes the tasks, taking account of the applicable company rules.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager household goods - interior advice works in the sector retail trade in particular the higher segment, in a range of shop formula, small and medium-sized enterprises and chain stores.

However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
