The dancer performs actively in the (commercial) theatre world, in television commerce and education. He works in dance productions, ranging from large to small companies, in commercial and subsidized productions. Giving simple workshops also belongs to the possibilities.

<p>Access to next level of education/professions Completion of this programme gives access to higher vocational education.</p> <p>It is very important that dancers already at an early stage start to think about their further career. Most dancers start to teach after a while. They work as freelance teachers then. Some start their own dance school. Part of the dancers searches a job outside the sector, for example as a sports masseur.</p>	<p>International agreements The profession of Artist - dance is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90031 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
