3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Maritime officer small ships are:

Core task 1: OL nautical A-II/1 (carries out the nautical tasks at operational level A-II/1 on small vessels)

- 1.1 Navigation at the operational level
- 1.2 Cargo handling and stowage at the operational level
- 1.3 Controlling the operation of the ship and care for persons on board at the operational level A-II/1

Core task 2: ML nautical A-II/2 (carries out the nautical tasks at management level A-II/2 on small vessels)

- 2.1 Navigation at the management level
- 2.2 Cargo handling and stowage at the management level
- 2.3 Controlling the operation of the ship and care for persons on board at the management level A-II/2

Core task 3: OL technical A-III/1 (carries out the nautical tasks at operationeel level A-III/1 on small vessels)

- 3.1 Marine engineering at the operational level
- 3.2 Electrical, electronic and control engineering at the operational level
- 3.3 Maintenance and repair at the operational level
- 3.4 Controlling the operation of the ship and care for persons on board at the operational level A-III/1

Core task 4: ML technical A-III/2 (carries out the nautical tasks at operationeel level A-III/2 on small vessels)

- 4.1 Marine engineering at the management level
- 4.2 Electrical, electronic and control engineering at the management level
- 4.3 Maintenance and repair at the management level
- 4.4 Controlling the operation of the ship and care for persons on board at the management level A-III/2

Core task 5: Carries out safety tasks (on small ships)

- 5.1 Prepares to handle in case of calamities and accidents
- 5.2 Manages and is in charge of life-saving vessels
- 5.3 Provides limited first aid in case of accidents and medical care in the event of sickness on board
- 5.4 Organises fire-fighting operations on board
- 5.5 Carries out maritime communication
- 5.6 Recognises and identifies potential threats
- 5.7 Carries out the security of the ship

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Maritime officer small ships (from now on Maritime officer) is employed in an internationally orientated professional environment. He sails on ships which can sail both short sea and worldwide, in, for instance, the break bulk cargo and dry bulk cargo, container transport, tank transport and project loads. The Maritime officer can according to the Maritime Crews Act work on ships sized less than 3000 GT (tonnage) and a capacity of less than 3000 kW (kilowatt). The professional practice has as its principle that the Maritime officer is a multifunctional Ship's officer which line of business requires a broad knowledge and skills. The Maritime officer's talents are used to the full on ships which business operation is integrated or on ships where a number of processes are supported by the shore.

Access to next level of education/professions The Maritime officer small ships starts as an officer with authority and after a certain sailing time and if proven competent, can attain the final position of captain and/or chief engineer for small ships. This entails managing other ship's officers and the other crewmembers. If there is a transfer to a position on shore there are possibilities for the Maritime officer small vessels in the harbour sector and the transport sector, with maritime aligned companies and in the process industry. On the basis of obtained qualifications he can move on vertically to level 4 courses in the shipping industry.	International agreements The profession of Maritime officer small ships is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95733 The education and training for this qualification is offered as of August 1, 2012.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
