## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor recreational company are:

An optimal service supply to customers, and complying with the requirements imposed with regard to business operation and business management. The Supervisor recreational company is employed in a co-ordinating capacity in a recreational establishment and his tasks include:

- business operation (determining the strategy on the department or business level);
- business management (taking care of the daily course of affairs, including human resources);
- relationship management (internal and external contacts).

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor recreational company is employed in a co-ordinating capacity in a recreational establishment (amusement park; camping; bungalow park et cetera).

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**Average duration of the education/ training leading to the certificate**

**4 year(s) (6400 study hours) (depending on previous education)**

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
