The most important duties of an Optician manager are:

- Refraction;
- Sales and advice;
- Processing, assembly and repair;
- Product range management;
- Sales promotion;
- As manager, performs his professional role.

The Optician manager organises the operations in his business and is responsible for the staff. He is also in charge of administration, manages product range and builds up and maintains a network. He implements the planned policy and participates in all policy discussions, but has no decision-making authority in that process.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Optician manager is able, as a self-employed business person, to perform his professional role.

5. OFFICIAL BASIS OF THE CERTIFICATE

Access to next level of education/professions

With a diploma at qualification level 4, transfer is possible to higher professional education.

International agreements

The profession of Optician manager is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 10911

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
