The All-round desktop publisher works for all kinds of companies in the field of media and communication: communication companies, advertising agencies, specialized design studios, sign and display companies, web design agencies, multimedia companies, publishers and printers. He can also work for other types of companies that have a design department and/or reproduction facility for in-house media productions.

Access to next level of education/professions

The All-round desktop publisher level 3 can do level 4 programmes, for instance Media technology and Media designer. Other level 4 media programmes, such as Media management, Audiovisual production, and Designing spatial presentation and communication, are possible, but will usually take additional study time.

International agreements

The profession of All-round desktop publisher is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90191 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
