### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor land, water and environment are:

The term land, water and environment covers all activities and the appropriate provisions related to the development and management of rural and urban areas, including infrastructure. The sector consists of mediumsized and larger enterprises as well as departments within governmental and semi-governmental organizations. The Supervisor land, water and environment carries out inspections of roads and waterways and takes the required measures in the event of calamities. He monitors the execution of work under his own management and/or outsourced work. He consults with other government institutions, groups and individual interested parties concerning execution of the work. He also gives guidance to other employees. The Supervisor is responsible for his own work and for employees working under him. There are few routine tasks. Considerable flexibility is expected of staff. Dealings with clients, principals and users of roads and waterways are also subject to high requirements. The work mainly involves very varied tasks in the area of leadership, guidance, administration (reporting), inspection, supervision, work preparation (road safety) and planning. Anticipation and decision-making in a wide variety of (traffic) situations that may arise are core characteristics of the work of a Supervisor.

However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
