3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Social worker are:

Charting out the material needs of the client, providing practical services, informing and advising on regulations/procedures or facilities, creating files/reporting and processing data, consulting and harmonising with other disciplines or care providers. Coordination, consultation and harmonisation are primarily linked to client-based activities. Depending on the position, the organisation and the target group, the central focus in these tasks may differ somewhat. In certain organisations, the focus is on activities in information and advice, file creation and mediation in the field of social security. Interacting with various client types and holding a range of discussion types are of key importance. In other organisations, the accent is placed on the support and supervision of at-risk target groups, in terms of their material needs. In these situations, psychosocial support and increasing selfreliance, provision of knowledge and skills are very important.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Social worker can be deployed in positions such as social services worker, (social) consultant, residents' affairs consultant, day care worker, positions in the field of information and advice provision (such as telephone care provider), in counter positions, as a complaints handler, process supervisor, parental advisor or budget consultant.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
