3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Aviation service provider are:

Core task 1: Provides support to passengers at the airport

- 1.1 Takes care of walkways
- 1.2 Handles baggage
- 1.3 Supervises at the full check-in service
- 1.4 Supervises the boarding process at the airport
- 1.5 Carries out inspections during the boarding process
- 1.6 Provides information to colleagues about the passengers on board
- 1.7 Supervises the disembarking process at the airport
- 1.8 Supervises passengers with special needs
- 1.9 Provides information
- 1.10 Makes in an inventory of complaints and wishes
- 1.11 Supervises problem passengers
- 1.12 Carries out (flight) safety procedures

Core task 2: Prepares the flight and provides support to passengers in the aircraft

- 2.1 Prepares for the flight
- 2.2 Inspects the equipment
- 2.3 Supervises during the boarding process in the aircraft
- 2.4 Takes care of passengers during the flight
- 2.5 Supervises during the disembarking process in the aircraft
- 2.6 Provides information
- 2.7 Makes in an inventory of complaints and wishes
- 2.8 Supervises problem passengers
- 2.9 Carries out (flight) safety procedures

The Aviation service provider works for an airline company, dealer, airport, or supporting company for the airline sector.

For instance, a teacher training or programmes in the field of communication, tourism, and event organization.</p>	<p>International agreements The profession of Aviation service provider is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
