3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Dental nurse are:

Core task 1: Take care of intake, information and advice

- 1.1 Speaks with the care recipient and channels the care demand
- 1.2 Gives information and advice

Core task 2: Contribute to dental care

- 2.1 Prepares the surgery, materials and instruments for the treatment
- 2.2 Assists the dentist with dental treatment
- 2.3 Carries out dental treatment independently
- 2.4 Supports and informs the care recipient

Core task 3: Perform organization- and profession-related duties

- 3.1 Participates in staff training and works on professionalization of the profession.
- 3.2 Works on the promotion and assurance of quality care
- 3.3 Consults about the work
- 3.4 Performs management duties
- 3.5 Performs administrative duties

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Dental nurse can work in various types of organizations, such as a general dentist's practice (both solo and group practice), dental centres, health centres, and hospital dental specialists. To a lesser degree the Dental nurse works in a regional institute for youth dental health care, nursing home, with a dental hygienist, (clinical) training in dental education programmes and in centres for special dental surgery.

<p>Access to next level of education/professions This programme gives access to higher vocational education (hbo), for example Oral hygiene.</p> <p>The qualified Dental nurse can possibly be granted exemptions from parts of other level 4 mbo programmes, such as Nurse (general care) or Dental technology. Through schooling and courses the Dental nurse can acquire further skills/specialize to become for example prevention assistant.</p>	<p>International agreements The profession of Dental nurse is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91410 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
