3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Deck officer small ships are:

Core task 1: OL nautical A-II/1 (carries out the nautical tasks at operational level A-II/1 on all small ships)

- 1.1 Navigation at the operational level
- 1.2 Cargo handling and stowage at the operational level
- 1.3 Controlling the operation of the ship and care for persons on board at the operational level A-II/1

Core task 2: ML nautical A-II/2 (carries out the nautical tasks at management level A-II/2 on all small ships)

- 2.1 Navigation at the management level
- 2.2 Cargo handling and stowage at the management level
- 2.3 Controlling the operation of the ship and care for persons on board at the management level A-II/2

Core task 3: Carries out safety tasks (on small ships)

- 3.1 Prepares to handle in times of calamities and accidents
- 3.2 Manages and is in charge of life-saving vessels
- 3.3 Provides limited first aid in case of accidents and medical care in the event of sickness on board
- 3.4 Organises fire-fighting operations on board
- 3.5 Carries out maritime communication
- 3.6 Recognises and identifies potential threats
- 3.7 Carries out the security of the ship

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Deck officer all small ships (from now on Deck officer) is employed in an internationally orientated professional environment. He sails on ships which can sail both short sea and worldwide, in, for instance, the break bulk cargo and dry bulk cargo, container transport, tank transport, and project loads. The Deck officer can according to the Maritime Crews Act work on with a capacity of less than 3000 GT (tonnage) and a capacity of less than 3000 kW. The professional practice has as its principle that the Deck officer a specialist employable and fully competent Deck officer is on all small ships which line of business requires broad knowledge and skills. The Deck officer's talents are used to the full on ships on which complex loading processes take place requiring thorough knowledge and skills.

<p>Access to next level of education/professions The Deck officer small ships starts as an officer with authority and after a certain sailing time and if proven competent, can attain the final position of captain and/or chief engineer for small ships. This entails managing other ship's officers and the other crewmembers. When the Deck officer small ships makes a transfer to shore there are possibilities for the Deck officer small ships in the harbour sector and transport sector, with maritime related companies and in the process industry.</p>	<p>International agreements The profession of Deck officer small ships is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
