3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sheet metal worker are:

Core task 1: Constructs products

- 1.1 Does preparatory work for one's own work
- 1.2 Sets and adjusts machine and tools
- 1.3 Manufactures and transforms material
- 1.4 Measures and checks manufactured products
- 1.5 Rounds off completed work

Core task 2: Produces sheet metal work products

- 2.1 Prepares sheet metal work
- 2.2 Carries out sheet metal work
- 2.3 Completes sheet metal work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Sheet metal worker produces simple sheet metal products for companies in the metal products industry. He has knowledge of the processing, shaping and connection of sheet material, metal and synthetic materials. He also understands the operation of various types of machines in his field.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
