The most important duties of an All-round machine operator wood working wood trade (level 3) are:

Core task 1: Processes wood using machines

- 1.1 Prepares machine working duties
- 1.2 Assembles production data
- 1.3 Selects, inspects and transports wood and sheet materials
- 1.4 Applies and adjusts cutting tools
- 1.5 Adjusts wood processing machines
- 1.6 Carries out test process
- 1.7 Carries out processes using wood processing machines
- 1.8 Packs processed materials
- 1.9 Clears up the workplace
- 1.10 Carries out simple maintenance

Core task 2: Supervises wood processing machine operators

- 2.1 Supervises and instructs
- 2.2 Monitors progress and quality
- 2.3 Reports to supervisor

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round machine operator wood working wood trade works for wood-processing companies who process various types of wood and sheet materials using machines. These can be companies in the timber or furniture industry, or wood industry.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

# Qualification level 3 of the Dutch VET qualification structure

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. ## Access to next level of education/professions

The most logical step for the All-round machine operator wood working wood trade is to become an assistant manager or planning officer (level 4). Another career opportunity for the All-round machine operator wood working wood trade is to broaden their working area by switching to an adjacent sector.

#### International agreements

The profession of All-round machine operator wood working wood trade (level 3) is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93531 The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
