3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Assistant fitter are:

The Assistant fitter assists in the installation of (pipe)lines for gas, water, sewage and central heating. He also connects water heaters, boilers, central heating boilers and radiators, and assists in the final installation and fitting of sink units, toilets and kitchens and bathrooms. Furthermore he can fit several types of roofing, gutters and rainwater drains.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Assistant fitter roofing technology is employed in an installation company that installs maintains and adapts installations for gas, water, central heating and sewage and carries out roofing technique activities. The work mainly takes place in homes, small office buildings, house building projects (series) and residential buildings (flats) but may also take place in large office and institutional buildings (such as hospitals, offices, schools).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
