### **3. PROFILE OF SKILLS AND COMPETENCES**

The most important duties of a Socio-cultural worker - recreational work are:

The Socio-cultural worker - recreational work organises activities and products with groups of different ages and from different socio-economic backgrounds. The activities are aimed at promoting social participation by target groups, with a view to improving the independence and self-reliance of the target group and improving the living. working and leisure climate.

The Socio-cultural worker is able to correctly assess individuals and groups (including clubs) and is ambitious to ensure that the opportunities offered are fully utilised. He has a positive view of people, believes that individual groups and clubs are open to influences, and wishes to use such influences to improve their quality of life. The Socio-cultural worker focuses on a specific area (district, neighbourhood or village) or an entire urban area in respect of a particular population group). He often works or from drop-in centres or community centres in combination with outreach work. He can also be employed in activities in the field of informal care provision.

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Socio-cultural worker - recreational work can be employed as general community worker, welfare worker, youth worker, club leader, worker in a neighbourhood (sports) centre, (development) worker in drop-in centres, playgrounds, youth centres and centres for women, educational worker in centres for adult education, centres for immigrants or asylum seekers centres.

International agreements The profession of Socio-cultural worker - recreational work is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
