The most important duties of an Assistant operational worker transport and logistics are:

The Assistant operational worker transport and logistics helps to load and unload the lorries. He gives signs during manoeuvring with the lorry and assists with linking or uncoupling the trailer. Furthermore he assists in preparing the ride and to load the goods, to anchor, to sort, to take, to make ready for mailing and to store. He also cooperates in the administration of the stored goods.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 1 year (1600 study hours) (depending on previous education)

### Entry requirements

There are no legal educational requirements.
