The most important duties of a Caretaker grazing animals assistant are:

Core task 1: Feeds and cares for animals

- 1.1 Prepares feeds
- 1.2 Is responsible for food and water provisions
- 1.3 Takes care of animals
- 1.4 Monitors animals
- 1.5 Handles animals
- 1.6 Registers and reports
- 1.7 Takes care of food production

Core task 2: Supervises reproduction

- 2.1 Supervises reproductive process
- 2.2 Supervises birth process

Core task 3: Takes care of the living and working environment

- 3.1 Organises the living accommodation
- 3.2 Cleans and disinfects
- 3.3 Maintains living and working environments
- 3.4 Takes care of grassland and grazing areas

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Caretaker grazing animals works in a company that keeps animals. There are companies that keep animals for semen collection, for rearing, or for the production of animals and/or animal's products. In addition, there are companies that keep animals for recreational, educational, sociocultural and/or therapeutic purposes. Finally, there are companies that keep animals for research purposes. The vocational context of animal keeper depends on the company system used.

### Access to next level of education/professions

Career opportunities for the specialization of Caretaker grazing animals are found in rising to animal keeper or business manager, or developing activities such as agritourism and agricultural nature conservation further.

### International agreements

The profession of Caretaker grazing animals is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97361 The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### Average duration of the education/ training leading to the certificate

3 year(s) (4800 study hours) (depending on previous education)

## **Entry requirements**

The certificate preparatory vocational secondary education (ymbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
