3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Security officer are:

Core task 1 Maintains preventive supervision of security

- 1.1 Carries out access and exit checks
- 1.2 Carries out surveillance and checks

Core task 2 Takes repressive action

- 2.1 Acts in the event of incidents and disasters
- 2.2 Detains suspects

Core task 3 Undertakes service tasks

- 3.1 Offers service and assistance
- 3.2 Carries out simple reception desk tasks

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The qualification Security officer is the basic training which everyone who wants to work in the private security has to receive. Think of building security officer, store security officer, mobile security officer, money security officer, personal security officer, money and valuable transport officer, supervision officer in detection, airport security guard. The context of the qualification Security officer is therefore very diverse. A lot of Security officers work posted to a client where they work alone or in a team. There are also Security officers who work for a regular company, at a company security service.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>2 years (3200 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
