## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Horse farm and equestrian sports worker are:

The Horse farm and equestrian sports worker performs simple executive activities independently after instruction and less simple executive activities under supervision. He cares for the horses and feeds them, performs cleaning and disinfection activities and carries out simple maintenance work to buildings, company gear, premises, planting in the yard and fencing.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Horse farm and equestrian sports worker can work as a caretaker for horses, as a professional horseman or as assistant in a horses clinic and can be active in a stud farm or mare breeding or in a riding school.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
