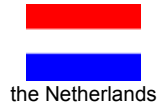

3. PROFILE OF SKILLS AND COMPETENCES
<p>The most important duties of an IT support worker are:</p> <p>Core task 1: Installing and maintaining hardware, software and network and infrastructure components</p> <p>1.1 Prepares devices for use</p> <p>1.2 Installs and maintains software</p> <p>1.3 Assembles network and infrastructure components</p> <p>Core task 2: Dealing with reports</p> <p>2.1 Receives and registers incoming reports</p> <p>2.2 Solves reports and escalates reports</p>

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE
<p>The IT support worker works at or for companies that use ICT systems. As a result, the work environment is very broad. He/she can be employed in small, medium-sized or large enterprises, profit and non-profit organisations, (commercial) businesses and certainly also (semi)government bodies. Depending on the size and/or structure of the organisation, work will often be carried out in a service-oriented environment, in which support to the client and users is of key importance.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.	

7. ADDITIONAL INFORMATION
Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at http://kwalificaties.s-bb.nl/ , only in Dutch. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate. The NRP is the information centre for vocational qualifications in the Netherlands. SBB has been appointed in this capacity by the Ministry of Education, Culture and Science.
