3. PROFILE OF SKILLS AND COMPETENCES

The most important tasks of a Basic operator are:

- operating, regulating and monitoring relatively simple devices and installations or assisting in the operation of complex installations and processes;
- supplying and removing raw materials, semi-manufactures and finished products;
- taking and possibly assessing samples:
- reporting orally and in writing about the status of the process;
- carrying out simple maintenance;
- carrying out washing and cleaning work;
- assisting in relatively complex maintenance.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The professional field process technology encompasses operative and middle management professions in the process industry. In the process industry, products are manufactured according to processes, i.e. step-by-step and often with automatically-operating equipment. Examples of the process industry are the (petro) chemical industry, paper and paper products industry, rubber and plastic processing industry, energy generation companies and pharmaceutical industry. The Basic operator carries out his duties on the basis of a thorough knowledge of a particular installation or sub-process. In other words, the qualification is strongly linked to a specific device or installati-

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
