#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Audiovisual specialist are:

Core task 1: Develops a concept and/or plan for the client

- 1.1 Consults about the wishes of the client
- 1.2 Carries out location investigations
- 1.3 Formulates concept and/or plan
- 1.4 Discusses concept and/or plan with the client
- 1.5 Makes a technical plan

Core task 2: Produces and adjusts light, image and/or sound

2.1 Provides instruction to others and tracks the progress

- 2.2 Gathers AV material and equipment, constructs it and takes it down after completion
- 2.3 Connects apparatus and installs it
- 2.4 Optimises the shooting location and/or styles the design and décor
- 2.5 Operates AV equipment during productions and recordings
- 2.6 Selects takes for the processing and/or editing
- 2.7 Revises and/or edits takes

Core task 3: Maintains and manages audio-visual materials and apparatus

- 3.1 Checks audio-visual material and apparatus and carries out simple maintenance
- 3.2 Manages the archive
- 3.3 Uses and registers the user rights

Core task 4: Carries out entrepreneurial tasks

4.1 Creates a plan for starting one's own business (working as sole proprietor)

4.2 Promotes his work

4.3 Organises administrative and financial matters

The AV-specialist is employed in the AV-sector and especially in the audio-visual production companies. The audio visual production companies can carry out a complete or partial realisation of programmes. They make audio

The AV-specialist works more and more as freelancer (zzp'er) which involves working with own facilities. He could be on the pay roll, or work on temporary contract basis.

Access to next level of education/professions A development to other specialist positions such as: camera man, video-editor, sound technician, light technician and image technician is possible. Also to managerial positions such as (assistant) production leader, project leader, coordinator, director or starting an own business. The AV-specialist can transfer to other mbo-courses. For instance, to adjoining courses within the qualification file Media designer or within the qualification file Stage technology and event technology. There are several audio-visual hbo courses such as Teacher trainer, Journalism, Film and television, communication courses, Visual art and design and the course Media and entertainment. Legal basis	International agreements The profession of Audiovisual specialist is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95704 The education and training for this qualification is offered as of August 1, 2012.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
