- 3.2 Carries out diagnosis working duties on mechanic mobile machinery or installation

- 4.1 Prepares the modification working duties
- 4.2 Carries out the modification working duties on mechanic mobile machinery
- 4.3 Completes the work

Core task 5: Inspects mobile machinery or installations

- 5.1 Prepares the inspection working duties
- 5.2 Carries out the inspection
- 5.3 Completes the inspection working duties

<p>Access to next level of education/professions An All-round mechanic mobile machinery can develop to a VET-level 4 qualification, such as the qualification Planner or Technician mobile machinery. Through further education and experience the All-round mechanic mobile machinery can develop to a supervising position, such as co-supervisor or workshop supervisor.</p>	<p>International agreements The profession of All-round mechanic mobile machinery is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
