- 1.6 Lays out parks and gardens
- 1.7 Rounds off the lay-out work

Core task 2: Keeps nature and living environment

- 2.1 Carries out soil improvement
- 2.2 Maintains water(ponds)
- 2.3 Maintains surfacing
- 2.4 Maintains constructional elements
- 2.5 Keeps parks and gardens
- 2.6 Leaves work environment well-kept

Core task 3: Takes care of public and spectators

- 3.1 Points out complaints and deals with them
- 3.2 Keeps in touch with public and spectators
- 3.3 Speaks to the public

Core task 4: Organizes and supervises work

- 4.1 Plans and spreads the work
- 4.2 Gives support in the technical field
- 4.3 Organizes materials and equipment

International agreements The profession of Skilled worker green space is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97252 The education and training for this qualification is offered as of August 1, 2008.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
